

#### 4. FIRST AID MEASURES

### A. Eye contact

- Do not rub your eyes.

# **5. FIREFIGHTING MEASURES**

#### A. Suitable (Unsuitable) extinguishing media

- Move container to safe area from the leak area.
- Must work against the wind, let the upwind people to evacuate.
- Remove all sources of ignition.
