4. FIRST AID MEASURES

- A. Eye contact
 - Do not rub your eyes.
 - Immediately flush eyes with plenty of water for at least 15 minutes and call a doctor/physician.
 - Get medical attention immediately.
 - Go to the hospital immediately if symptoms(flare, irritate) occur.
 - Remove contact lenses if worn.

B. Skin contact

- Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes.
- Wash contaminated clothing thoroughly before re-using.
- Accidental contact with liquefied gas or refrigerated liquefied gas may cause burn, severe mayhem and perfrigeration, so please take emergency medical action.
- Get medical attention immediately.
- In case of accidental contact with liquefied gas or refrigerated liquefied gas, warm up the contact part with lukewarm water.

C. Inhalation contact

- Take specific treatment if needed.
- When exposed to large amounts of steam and mist, move to fresh air.
- Get medical attention immediately.

5. FIREFIGHTING MEASURES

A. Suitable (Unsuitable) extinguishing media

- Avoid use of water jet for extinguishing

B. Specific hazards arising from the chemical

- Compressed gas ; Contains gas under pressure; may explode if heated

C. Special protective actions for firefighters

6. ACCIDENTAL RELEASE MEASURES

- A. Personal precautions, protective equipment and emergency procedures
 - Do not touch spilled material. Stop leak if you can do it without risk.
 - Handle the damaged containers or spilled material after wearing appropriate protective equipment
 - Move container to safe area from the leak area.
 - Must work against the wind, let the upwind people to evacuate.
 - Remove all sources of ignition.

- If large amounts have been spilled, inform the relevant authorities.
- Prevent runoff and contact with waterways, drains or sewers.

C. Methods and materials for containment and cleaning up

- Appropriate container for disposal of spilled material collected

- Large spill : Stay upwind and keep out of low areas. Dike for later disposal.
- Notify the central and local government if the emission reach the standard threshold.
